Privacy and cookies policy

Sandbach Animal Rescue Society is committed to safeguarding and preserving the privacy of our clients and website visitors. This policy explains what happens to any personal data that you provide to us, or that we collect from you whilst you visit our site or complete adoption or surrender forms.

Information we collect:

In running and maintaining our website we may collect and process the following data about you:

Information about your use of our site including details of your visits such as pages viewed and the resources that you access. Such information includes traffic data, location data and other communication data.

Information provided voluntarily by you. For example, when you register for information or make a purchase, adoption or surrender. This includes information that you provide when you communicate with us by any means.

Use of cookies:

Our Website tracks two forms of cookie:

Absolutely Necessary Cookies

Google Analytics Cookies

As standard all of our websites only create two Cookies and these cookies are 'Absolutely Necessary' for the functioning of your website. These cookies are 'ASP.NET_SessionId' and "JSESSIONID". 'ASP.NET_SessionId' stores a 'Session ID' which is used by Microsoft .NET Framework to deliver the web pages to the visitor.

The New Relic JSESSIONID cookie is used to store a session identifier so that New Relic can monitor session counts for our applications. The cookie value is generated by Jetty.

We use New Relic to help us track any potential server errors and review the performance of our hosting platforms.

These cookies expire at the end of sessions which is when a visitor goes to another website or closes their browser window.

Because they do not remain on your computer it has no way of tracking your website usage or retaining any of your data post expiry. This means consent is not required.
